

#### **Technical specification**

#### Fabrication of circular U-bend test mock-up

#### 1. Introduction:

The Pb-Li MHD loop has been developed at IPR to perform the MHD studies in the test mockups with different flow configurations. The fabrication of U-bend MHD test mock up having circular flow cross-section (I.D. =52.48mm, O.D. = 60.3mm) has been planned. The test mockup will be integrated with the Pb-Li MHD loop to perform the MHD experiments. The picture of the test mock-up is shown in **Fig.1**. The test mock-up will be equipped with the large number of potential pins (~72Nos.) and thermo-couple ports (32 Nos.) for wall electric potential and temperature measurements respectively. The reference drawing is given in **Annexure-I**.



**Fig.1.** Picture of the test mock up.TC-1, TC-2, TC-3 & TC-4 are the cross-sectional locations of thermocouple ports. PP-1, PP -2, PP -3 & PP -4 are the cross-sectional location of potential pins.

#### 2. Scope of the work:

This work involves procurement of material, fabrication of the test mock up, hydro test, pressure test and helium leak test of the test mockup. All the welding should be performed by qualified vendor as per standard codes. The test mockup will be fabricated along with the required diagnostics. The locations as well as numbers of the diagnostics and its welding strategies are given in **Annexure-I** and **Annexure-II**.

- 2(i). Vendor should study the engineering drawings of the test mock up given by IPR (Refer Annexure-1) and prepare detail fabrication drawings. Vendor may suggest any modifications in the drawings with justification. IPR will review those suggestions and may accept, if found suitable. Based on the IPR feedback, the vendor shall prepare the final fabrication drawing.
- 2(ii). Vendor shall not proceed for fabrication without IPR approval. The vendor shall fabricate the test mock up as per the approved fabrication drawings. The detail fabrication drawings based on the engineering drawing provided by the IPR should be prepared and submitted to IPR for approval prior to the test mock up fabrication.
- 2(iii). Vendor shall procure the required materials as per the required specifications (**Refer Sec.3**) and submit the material test certificate obtained from the government approved labs.
- 2(iv). Vendors shall follow the prescribed codes and standards for materials procurement, fabrication and testing of the test mock up (**Refer Sec. 5**).
- 2(v). Pre-dispatch inspection (PDI) will be performed by IPR representatives at vendor's site as per the tests described in **Section 8**.
- 2(vi). For PDI at vendor site, vendor shall write to IPR Purchase officer informing the status of fabrication of the test mock up and their readiness to perform the PDI, well in advance (preferably 1 week before).
- 2(vii). Vendor shall arrange all the required test facilities and instrumentation for the PDI at their site. (e.g. Necessary equipment for the helium leak test, hydro-test, electrical testing of potential pins etc.).
- 2(viii). All the PDI test results should confirm to the technical specifications mentioned in the purchase order. Based on the submission of PDI test results to IPR and its acceptance, dispatch clearance will be provided by Purchase Officer, IPR.
- 2(ix). Before shipment, vendors shall clean the Test mock-up properly, free from any moisture, water etc. and pack them as per the requirements mentioned in **section 11**.

- 2(x). After delivery of shipment at IPR, acceptance tests will be performed by IPR as per the details mentioned in **section 9**.
- 2(xi). The test mock-up will be accepted only after the successful completion of site acceptance tests at IPR.
- 2(xii). Vendor shall submit the final fabrication drawings (as built), material certificates and other test certificates along with the shipment.

#### 3. Material:

The test mock up should be fabricated with the standard 2"pipe made of SS316L. For temperature measurement, standard 1/4" stainless steel pipe with the length of ~100mm will be welded on the test mock up at each temperature measuring location after making hole ( $\Phi$ ~8mm) on the test mock up as mentioned in **Annexure-II**. For the wall electric potential measurement, rods ( $\Phi$ ~1.5mm) made of SS316L will be used as mentioned in **Annexure-II**. All the required material (SS316L rods, and pipe etc.) should be procured by vendor and test reports should be submitted to IPR before starting of the fabrication.

**4. Fabrication Requirement:** The test mockup shall be fabricated as per the procedure given in **Annexure-II**.

#### 5. Codes and standards:

The test mock up should be fabricated and tested as per the ASME standard.

- **6. Inspection Test and Reports:** The procurement of material and fabrication work should start after receiving the approval from IPR.
- 7. **Documentation:** Following documents should be submitted
  - a. Material test certificates
  - b. Dimension Inspection report
  - c. DP (Dye penetrant ) and RT (Radio graphic) test report
  - d. Hydro test report
  - e. Helium leak test report

#### 8. Acceptance test as Vendor site:

The test mock up, after completion of fabrication, will be tested at vendor's site. IPR authorised representative will witness the test. Following test will be performed.


- a. Standard Dimensional checks: The test mock-up will be subjected to standard dimensional checks.
- b. Standard Pneumatic Test: The test mock-up will be held at the test pressure for minimum of 30 minutes. Vendor has to demonstrate no leakage at room temperature up


- to 5bar pressure for nearly 30 minutes. In addition Helium leak test should also be performed.
- c. Electrical testing of the potential pins


**Note:** - It should be noted that the vendor has to arrange all the test facilities at his site for the above—mentioned test.

- **9.** Acceptance test as IPR: After delivery of the fabricated test mock up at IPR, visual inspection for any damage followed by Helium leak test will be carried out by IPR.
- **10. Deliverable:** A test mockup with the attached diagnostics, fabrication drawings, documents mentioned in **Section-7**.
- **11. Delivery Period:** The delivery shall be made within 8 weeks after placement of the purchase order and subsequent acceptance by the vendor. Item should be properly packed in a wooden box. 









1. **Potential Pin Welding Strategy:** For electric potential measurement, a stainless steel (SS316L) rod (Φ~1.5mm) of sufficient length (~100mm) will be welded on the test mockup. On the outer side of the pipe, hole of Φ~2.0mm for a depth of 1.5mm would be made; rod will be inserted and welded (TIG welding) from outside as shown in **Fig.1**.



**Fig.1** Schematic of welding of the potential pins on the pipe

2. Welding Strategy of thermo well in the pipe of test mock-up: Thermo-well will be used for insertion of thermocouples. Initially a hole will be made on the pipe of test mock up as shown in Fig.2a. One end of thermo-well tube (length ~100mm) will be grinded in curve form. Further a support plug will be inserted into the pipe of test mock-up to support the thermo-well tube. Thereafter grinded end of thermo-well tube will be inserted into drilled hole (Φ~8mm) and weld tag will be performed between the surface of pipe of the test mock-up and thermo-well tube as shown in Fig.2b.
