

ELIGIBILITY CRITERIA:

(The bidder is required to submit all supporting documents as proof for the compliance of the following criteria. The attachments must be serially labelled with the number as given in the table below. Bids received without valid documents and/or incomplete and irrelevant documents are likely to be rejected summarily)

1.	The bidder should be an OEM (Original Equipment Manufacturer) or an authorized dealer of the OEM	<p>In case the bidder is an OEM, provide company profile for OEM products in compliance to relevant Indian standards along with a certificate issued by a competent authority showing therein that bidder is an OEM of the tendered item.</p> <p>In case the bidder is an authorized dealer of OEM, he should provide the company profile of the OEM products in compliance to relevant Indian standards along with copy of valid agreement/dealership certificate of OEM showing that the bidder is authorized to quote on behalf OEM and OEM shall support the bidder for all technical support, warranty etc.</p>	
2.	The Bidder/OEM should have successfully supplied and commissioned 11kV class or above and 2.5MVA rating or above cast resin transformer in the last five (5) years i.e. 2012-13 to 2016-17.	Copy of purchase orders (unpriced) along with technical details.	
3.	The bidder/OEM must have executed single order of similar work of value not less than Rs.18 Lakhs and above in the last five financial years (i.e. 2012-13 to 2016-17)	Copy of purchase order/s (priced) along with one similar successfully completed work specific to dry type transformer with technical details along with work completion/installation certificate during the financial year 2012-13 to 2016-17 to be provided as a proof.	

4.	Similar type of transformers should have been type tested for 11kV class in the last 8 years (i.e. 2009-10 to 2016-17)	Copy of detailed tests report for Short Circuit for similar type of transformer supplied in the financial years 2009-10 to 2016-17 should be provided as a proof.	
5.	The bidder/OEM should have an average annual turnover of at least Rs.61 Lakhs or above for the past 3 financial years (i.e. 2014-15 to 2016-17) and should not have suffered loss for more than one year out of the last three years (i.e. 2014-15 to 2016-17).	Audited balance sheet and Profit & Loss Account for the past 3 financial years (i.e. 2014-15 to 2016-17) to be submitted as a proof.	

Note: Original documents shall be produced for verifications, if required.

The response to tender without submission of proof of above points will summarily be rejected without further communication.

NOTE: Issue of tender documents does not mean that a vendor is qualified to submit tenders. IPR's decision to consider as to whether a vendor has met with the eligibility criteria is final.
