5.	Wherever CGPA/ SGPA or letter grade is awarded; equivalent percentage of marks should be		
	indicated in the online application form as per norms adopted by the University/Institute.		
	Candidates would be required to produce CGPA to Percentage conversion formula of their		
	Institute/University at the time of document verification.		
6.	Selection will be solely on merit based on percentage of marks in respective Degree/ Diploma		
	in engineering. Any form of canvassing will result in cancellation of candidature.		
7.	The engagement and training are strictly in compliance with the provisions of the Apprentices Act 1961 and 1973 (as amended from time to time) and Apprenticeship Rules 1992.		
8.	Name and Date of Birth as recorded in the Birth Certificate / Secondary School Leaving		
	Certificate (SSLC)/ Matriculation / Secondary School Certificate shall be the only acceptable		
	Document in support of proof of age.		
9.	The list of selected candidates will be displayed on IPR website.		
10.	The candidature of the selected applicant would be provisional and subject to subsequent		
	verification of certificates/ testimonials, medical fitness etc.		
11.	Accommodation facility will not be provided to apprentices during the apprenticeship period. The apprentices shall make their own arrangement for accommodation.		
12.	No TA/DA will be paid for attending physical verification of documents or at the time of Commencement of the apprenticeship.		
13.	At any stage of the selection process, if it is found that the candidate has furnished false or Incorrect information, the candidature of the candidate will be cancelled.
