- (2) Registration certificate of the firm, P.F., ESI/WCA and Service Tax Registration Certificates.
- (3) Valid ISO 9001-2008/2015 certificate.
- (4) The party shall have a minimum five years of experience of similar EPRJ work at any Government /Semi Government Institution or reputed Organization.
- (5) Presently the bidder must be having a running contract for similar work.
- (6) During the last five years (starting from 1st April, 2012), the bidder must have undertaken and completed the similar works for a minimum one year period at any Government /Semi Government Institution or reputed Organization.
 - (a) Atleast one work contract for minimum area of 40,000 Sqmt.
 - or
 - (b) Atleast two work contracts for minimum area of 30,000 Sqmt each
 - or
 - (c) Atleast three work contracts for minimum area of 20,000 Sqmt each.
- (7) Valid bank solvency certificate of ₹10 lacs from nationalized/scheduled bank.
- (8) Average annual turnover during last three financial years should not be less than ₹2.00 crores (audited balance sheet and profit & loss statement should be submitted i.e 2013-14, 2014-15 & 2015-16).
